Implementation of important infrastructure projects like the road Burgas – Slanchev Bryag, the road junction West, a new building of the Urgent Medical unit in the town, cleaning of river beds – these subjects were among all discussed during the meeting of the Governor Valcho Cholakov with Members of Parliament from Burgas region. A number of legislative changes related to the powers of Governors and their capacity to protect state property and education including finish of the building of the Public Health Faculty were also a part of the agenda.

“The idea of today’s meeting between executive and legislature is to declare our common wish to work together on the problems which have gathered head and on important projects for Burgas region. Despite the political priorities of everyone there are topics of extreme importance for the Region and we must unite about them and run them together.” – with these words the Governor made the start with the discussions. One of the problems demanding a speedy solution is the financing for cleaning of river beds. Every year a commission appointed by the Governor controls their capacity. The last report for requesting financial means for prevention is of September 2014 and the amount needed on the basis of cost-quantitative calculations elaborated in the municipalities is round about 2 Million BGN.

The Governor’s administration faces absurd cases in its work and their solutions take up undue much time because of lack of legal opportunities for solving them on regional level. Therefore in order to finish requests of citizens, institutions and companies in normal time limits it is necessary to be taken a legislative change for local administrations to obtain more powers of administrating and control. The Members of Parliament suggested the preparation of a proposal with concrete legislative initiatives which should be supported by the most regions, because these difficulties occur in all administrations. Cholakov committed himself to send the request from Burgas, so immediate actions can be started on the administrative burden to die out. If this happens Governors will have also more instruments for regular administering of state property which is to date in poor condition.

Another problem supported by everyone who were present was the financing for finishing the building of the new Health Care Faculty. The total amount needed for the construction of the building is approx. 6 Million BGN. On projecting and started construction works 500 000 BGN have been spent till now. According to information of the Deputy Chairman of the Budget Commission – Diana Yordanova conversations have been conducted and it continues to be a priority task. The modern equipment shall be the reason for the Public Health Faculty to fight for becoming a Medicine Faculty with a main function for postgraduate qualification of doctors. This is a significant step forward to enhancement of health care in Burgas region, it means a possibility to be supplied with a hightechnological equipment and start of scientific career for specialists in Burgas.

The Executive and Legislature have united about common actions in preventing malpractices in wood industry and wood transportation and correct exploitation of dams as well.

The participants in the meeting rated it as highly useful. They decided that such meetings will be held once after every two months in order to follow how are developing projects important for the Region and to plan new projects.

In the meeting took part Members of Parliament of following political parties: GERB, Reformatorski Block, BSP, DPS and ABV
